AUTHORIZING AWARD OF CONTRACT FOR SANITARY SEWER COLLECTION SYSTEM REHABILITATION (PHASE V)

- **WHEREAS**, the Township of Upper Deerfield has advertised for bids for Phase V of the rehabilitation of the Sanitary Sewer Collection System in Seabrook; and
- **WHEREAS**, bids were received by the Township of Upper Deerfield on June 30, 2015 from Ricky Slade Construction \$410,360.00, Fred M Schiavone Construction \$376,937.00, Perna Finnigan \$527,772.75. North American Pipeline, Video Pipe Services and T & W Construction also picked up bid packets but did not submit a proposal; and
- **WHEREAS**, the low base bid was received from Fred M Schiavone Construction in the amount of \$376,937.00; and
- **WHEREAS**, the bids have been reviewed by the Township Engineer, and a recommendation received that the base bid in the amount of \$376,937.00 is the lowest responsible bid and Fred M Schiavone Construction is the lowest responsible bidder; and
- **WHEREAS**, the Township Committee of the Township of Upper Deerfield is desirous of awarding the contract to Fred M Schiavone Construction in the amount of \$376,937.00 for Phase V of the rehabilitation of the Sanitary Sewer Collection System in Seabrook pursuant to the bidding documents;
- **WHEREAS**, the award of the aforesaid bid to Fred M Schiavone Construction is in accordance with the provisions of Pay to Play, <u>N.J.S.A.</u> 19:44A-20.4, et seq. in that the bids were publicly advertised and awarded;
- **NOW THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Upper Deerfield that the base bid of Fred M Schiavone Construction in the amount of \$376,937.00 for Phase V of the rehabilitation of the Sanitary Sewer Collection System in Seabrook, in accordance with plans and specifications is hereby awarded; and
- **BE IT FURTHER RESOLVED** by the Township Committee of the Township of Upper Deerfield that the award of this bid is subject to and conditioned upon a certification of available funds being filed by the Chief Financial Officer of the Township of Upper Deerfield; and
- **BE IT FURTHER RESOLVED** by the Township Committee of the Township of Upper Deerfield that the Mayor and Clerk be and are hereby authorized to enter into a contract with Fred M Schiavone Construction for such services in form satisfactory to the Solicitor of the Township of Upper Deerfield; and
- **BE IT FURTHER RESOLVED** by the Township Committee of the Township of Upper Deerfield that bid bonds may be returned to the unsuccessful bidders.
